



## **COMPLIANCE WITH CITY ORDINANCE NO. 14-03** (Ordinance Requiring the Installation of CCTV Cameras in Business Establishment)

### **ESTABLISHMENTS COVERED:**

- BANKS;
- SHOPPING MALLS AND THEIR TENANTS WITH DOORS;
- GASOLINE REFILLING/ SERVICE STATION;
- SUPERMARKET;
- MONEY CHANGERS;
- 24-HOUR CONVENIENCE STORES;
- SCHOOLS INCLUDING COLLEGE AND UNIVERSITIES;
- FAST FOOD/ QUICK SERVICE RESTAURANT;
- CAR DEALERSHIP;
- PAWNSHOPS;
- MONEY COURIER AND MONEY WIRE TRANSFER;
- GAMES AND AMUSEMENT CENTER DULY ACCREDITED BY PAGCOR;
- BAR;
- HEALTH CLUBS, SPA AND MASSAGE PARLORS;
- HOTELS AND ALIKE;
- OTHER ESTABLISHMENTS WHICH OPERATE, TRANSACT AND /OR DEAL WITH ANY OF THE FOLLOWING, WHICHEVER WILL APPLY:
  - (I) BUSINESS ESTABLISHMENTS THAT HANDLE MONETARY TRANSACTIONS IN THE REGULAR COURSE OF BUSINESS AMOUNTING TO THE EXCHANGE OF GOODS AND/OR SERVICES FOR DAILY AVERAGE AMOUNT OF MORE THAN FIFTY-THOUSAND PESOS PHP 50,000.00}; AND
  - (II) BUSINESS ESTABLISHMENTS THAT TRANSACT AN AVERAGE DAILY BASIS WITH MORE THAN TWO HUNDRED (200) CLIENTS.
- PRIVATE SUBDIVISIONS – ENTRANCE AND EXIT GATES OF RESIDENTIAL SUBDIVISIONS.

### **LISTED BUSINESS ESTABLISHMENTS ABOVE SHALL BE REQUIRED TO SUBMIT THE FOLLOWING:**

CERTIFICATION THAT THE BUSINESS ESTABLISHMENT HAVE INSTALLED CCTV CAMERAS (AND ARE COMPLIANT WITH SECTION 5 OF THE ORDINANCE); or

CERTIFICATION FROM THE CCTV SERVICE PROVIDERS (THAT THEY HAVE DULY INSTALLED THE REQUIRED CCTV CAMERA); and

PICTURES SHOWING THE INSTALLED CCTV CAMERAS (PLEASE INCLUDE A PHOTO OF THE CCTV'S VIEWING FUNCTION)
